## **Call to Order and Determination of Quorum:**

Those present represent a quorum. Andrea called the meeting to order at 7:00 pm. Directly after calling the meeting to order, Andrea announced George Lagos' resignation letter. The Board accepted George's resignation, and will run as a 4 member Board until such time a new, 5<sup>th</sup>, Board member is appointed.

<u>Approval of Minutes:</u> Irv Reifler made a **motion** to approve the minutes of the November 11 and November 18, 2015 Board meetings. The **motion** was seconded by Eric Larriviere and the motion carried unanimously.

<u>Financial Report:</u> Irv reported from the December 2015 financials saying it is very similar to last month with all activity to date on track, equity is increasing and the Association is in good financial condition. There is \$376,483 in the operating accounts and \$373,459 in the reserve accounts giving total cash position of \$749,942. With assets of \$747,116 and liabilities of \$51,980 equity stands at \$695,136. All lines items are at or near projected amounts.

Accounts receivable were reviewed with questions and discussion. One delinquent account is a bank foreclosure and bankruptcy which puts collection efforts on hold. The bankruptcy is still in effect, and there has been no change with that account. AR is still very good and greatly improved over the last 2 years. Irv went over the informational notes from the CPA's letter on their review.
