## **Call to Order and Determination of Quorum:**

Total Assets are \$736,537, current liabilities are \$100,577, and equity is \$635,960. All lines items are at or near projected amounts.

Accounts receivable were reviewed with questions and discussion. Irv asked why the Security line item expenses were at \$0. Envera Security Systems is just late in their billing and this should even out down the road. One delinquent account is a bank foreclosure and bankruptcy which puts collection efforts on hold. The bankruptcy is still in effect, and there has been no change with that account.
