MINUTES

Call to Order and Determination of Quorum

Present were: Andrea "Andi" Ciampi, President; James Levin, Treasurer and Director Nick Bereschak and Secretary, Allen Arnett. Eric Larriviere was absent. Those present represented a quorum.

The A/R report is still in great good shape with only 1 resident in arrears and arrangements have been made for payment. We ended slightly over budget for expenses by \$353 with a net surplus of \$1,372. Andi thanked Jim for his great work.

Tennis Court – Andi asked Paul Trupia to report. He stated that he was not aware of any issues.

Radar signs data – Nick reported that speeding results are getting better. It was suggested to turn the sign around in the other direction on Bent Tree. Nick and Allen will take care of this.

Violations – Patti reported that there is one home to be fined. Andi made a motion to fine \$50 a day for the side of the house that has not been cleaned. The motion was seconded by Jim and the motion carried unanimously.

Sales and Leasing – Patti reported that there were 10 sales in 2020 and currently 13 leases. Andi stated that there are 3 noted as grandfathered in but believes there are more and she will work with Patti on this.

Welcome Committee – There are no new residents yet this year.

Manager Report – Patti reported that she met with City Forester today and walked the buffer behind 14 homes. The website has been update with the October minutes and the 2019 annual minutes, the new fountain and lake company seem to be doing well. The pool coping has been repaired, 2 stop signs have been straightened.

New Business: -

Hotwire proposal – Jim gave an overview of the recent meetings held with Hotwire and went over some of the pros and cons as well as the costs savings. The association agreed to put out a survey to determine interest. Jim agreed to prepare a draft.
