## Call to Order and Determination of Quorum: Present:

Those present represent a quorum. Andrea called the meeting to order at 7:16 pm.

**Approval of Minutes:** The minutes of the November 12, 2014 Board meeting were reviewed by the Board. A **motion** by Irv to approve the minutes as submitted was seconded by George and passed unanimously.

**Financial Report:** Irv reported from the December 31, 2014 ending statement saying the Community is good financial condition. There is \$293,229 cash in the operating accounts, \$300,618 in the Reserve accounts for a total cash position of \$593,847. With Other assets of \$19,362 and current Liabilities of \$40,033 Owner Equity stands at \$573,176. Year to date income is \$418,801 with expenses of \$323,513 leaving an YTD budget surplus of \$95,287. The Board reviewed AR and discussed delinquent accounts in the Community. Current AR is \$14,428 of which near \$10,000 represents one bank foreclosure which is expected to be resolved soon. He said the budget surplus comes from over \$23,000 in recovered income and a change in landscaping companies. Irv concluded by saying this is the best receivables we have seen in years with only two accounts of any concern. AR was reviewed with Allen.

## **Committee Reports:**

**ARC** – Irv reported there have been 4 requests since the last meeting which were approved.

- 150 BT remove dead queen palm replace with a foxtail palm
- 154 BT remove oversized oak tree from front yard
- 128 BT new door initially denied because of color but resolved with a color change
- 132 BT remove oversized oak tree from front yard

**Landscape** – Andi reported weeds are a problem throughout the Community. She mentioned the future installation of irrigation at two new locations was budgeted for this year.

**Pool** – Andi reported pool is good with nothing in particular to report

Welcome: Kathy Sorkin was not in attendance and there was no report.

**Old Business:** There was no old business before the Board.

**New Business:** The Board reviewed a quote to refurbish street light poles Community wide directing Allen to approve and schedule. There was open discussion about the formation of a Compliance (Fining) Committee. The Board asked Allen to find a company large enough to provide a quote to replace sod Community wide. There was open discussion about the proposed I-95 interchange at Central Blvd.

**Adjournment:** Meeting was duly adjourned at 8:30 pm.

**Open Forum:** There were comments, concerns and suggestions from the Membership including asking the Board to consider allowing more colors for home than is currently approved.
